A. CALL TO ORDER

The April 19, 2022, Special Board Meeting of the Caribe Palm Community Development District (the “District”) was called to order at 7:02 p.m. at the Silver Palms Mailbox Kiosk located at 23020 SW 113th Passage, Miami, Florida 33170.

B. PROOF OF PUBLICATION

Mr. Silva informed the board that per the Bonds Trust Indenture, optional redemption eligibility begins with bonds maturing after 5/1/2025 on any date on or after 5/1/2025. This means that the District can make an extraordinary payment on the bonds to assist with paying off the bonds earlier.
