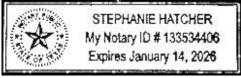

A. CALL TO ORDER

The February 3, 2025, Regular Board Meeting of the Caribe Palm Community Development District (the "District") was called to order at 6:50 p.m.

B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the February 3, 2025, Regular Board Meeting had been published in *The Miami Herald* on September 20, 2024, as part of the District's Fiscal Year 2024/2025 Meeting Schedule, as legally required.

C. ESTABLISH A QUORUM

It was determined that the attendance of Chairperson Madeline Martin, Vice Chairperson Merlin Nicieza and Supervisors Carmen Maseda, Hery Morales (who arrived at 6:53 p.m.) and Robert Fox constituted a quorum and it was in order to proceed with the meeting.

Staff present: District Manager Armando Silva and Associate District Manager Pablo Jerez of Special District Services, Inc.

Others in attendance: Ms. Alicen Gonzalez, Miami, FL.

D. ADDITIONS OR DELETIONS TO AGENDA

There were no additions or deletions to the agenda.

E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

F. APPROVAL OF MINUTES

1. January 20, 2025, Special Board Meeting

The minutes of the January 20, 2025, Special Board Meeting were presented and the Board was asked if there were any changes. There being no changes, a **motion** was made by Ms. Maseda, seconded by Mr. Morales and unanimously passed approving the minutes of the January 20, 2025, Special Board Meeting, as presented.

1. Discussion Regarding Cameras Permit – Phase III

Mr. Silva advised that all information requested by Miami-Dade County had been submitted and was pending approval. The Board elected to wait until the approval has been received in order to avoid any future delays.

1. Discussion Regarding Purchase of a New Storage

Mr. Silva presented the three estimates received from Shed Depot, Amazon Sheds, and State of the Art Marble & Granite, respectively. A discussion ensued where certain specifications for the shed arose. The Board would like to proceed with a shed with a window, shelving, and properly permitted from Miami-Dade County. District Field Operations Staff will research and provide Mr. Silva with the adjusted proposals with final pricing. A discussion ensued after which;

A **motion** was made by Ms. Maseda, seconded by Ms. Nicieza and unanimously passed approving an amount not to exceed of \$5,500 for the purchase, installation and permitting of the storage shed.

There were no administrative or operational matters to discuss at this time.

There were no Board member or staff closing comments.
